 - (c) Review the Annual General Plan Status Report and direct staff to forward a copy of the report to the California Department of Housing and Community Development.
 - (d) Approve downtown event application for the Music in the Park series in Creek Park on Sundays, July 10 to August 22, 1-4 p.m.
 - (e) Announce terms expirations on the Library Advisory Board and Park and Recreation Commission and authorize advertising for applicants.
 2. Appoint members to the Capital Program Monitoring Committee (two seats) and Quality of Life Commission (two seats).
 3. Acknowledge and file 3rd quarter report on the 2010 Goals and Objectives.
 4. Study Session on the Town's budget structure and budget document and initial projections for 2010-11 revenue. (oral session)
