SUBJECT: Parks and Recreation Commission – Youth Commissioner

RECOMMENDATION

That Council approve the recommendation from the Parks and Recreation Commission to appoint Kelsey Lopin to the Parks and Recreation Commission as the 2010/11 Youth Commissioner.

BACKGROUND

In March of 2009, the Council approved an amendment to San Anselmo Municipal Code, Title 11, Chapter 2.02 that added a youth member position to the Parks and Recreation Commission. The Parks and Recreation Commission made this recommendation in an effort to provide better representation on the Commission of the interests of youth and teens. The Commission also considers the Youth Commissioner position as an opportunity to provide leadership development and mentoring to the Youth Commissioner.

DISCUSSION

The Commission conducted a recruitment process, working with administrators at Drake and Marin Catholic High Schools. Two applications were submitted by the May 11th deadline, and the two candidates were interviewed at the Parks and Recreation Commission meeting on May 18th. The Youth Commissioner will have full voting rights and will serve a single one-year term, serving from July 2010 until June 2011.
